1. Appointment as Scrutinizer:

2. Our Responsibility

The management of the Company is responsible to ensure the compliance with the requirements of the Act, Rules and notifications and SEBI Listing Regulations relating to voting through electronic means on the businesses set out in the Notice of the 65th AGM of the Members of the Company. 3. Dispatch of Notice convening AGM
